## TERMS AND CONDITIONS – IPAD USE STUDENT OWNED

- PARTIES TO WHOM THESE TERMS AND CONDITIONS APPLY**  
These terms and conditions apply to the student intending to use their own iPad and their parent/guardian.
- OWNERSHIP**  
The student and parent own the iPad.
- PURPOSE**  
The iPad is for the exclusive use of the student in support of their learning.
- SCHOOL POLICIES**  
The student agrees to fully support the School in the implementation of rules, policies and procedures relating to student use of technology as outlined in the **ICT Acceptable Use Policy**.
- REPAIRS AND REPLACEMENTS**  
All iPad repairs/replacements should be arranged through an authorised dealer and not the School, in the event that it is not operating correctly, any part of it is broken; it sustains any form of damage or is missing. The School will not authorise repairs. All repairs must be undertaken via an Authorised Apple Retailer.  
  
Parents/Guardians will be responsible for the full cost of any repairs. In the event that the device is lost or stolen, parents/guardians shall bear the full replacement cost.  
  
Students should regularly back up their data through iTunes (please see details in the Student iPad Manual).
- IPAD CARE**  
Students are responsible for taking care of the iPad. The student shall at all times take responsible care of the iPad and not expose it to undue risk of damage or theft. When transporting the iPad it should be carried in a protective case. The students will ensure the iPad is recharged at home each night.
