Dear Parents

The Premier, Mr Andrews, announced yesterday details of the state government's complex 'roadmap' for the gradual easing of COVID-19 restrictions. The announcement includes important measures affecting schools.

He said the 'staggered and measured' opening up of the state was 'inevitable' as the state moved towards the targets of 70 and 80 per cent of the eligible population fully vaccinated.

Following is a summary of measures affecting schools. The dates are indicative, depending on vaccination levels.

Metropolitan Melbourne

From **October 5**, in addition to vulnerable children and the children of authorised workers, schools will be open for GAT students. Oakleigh Grammar will maintain the student supervision program for all students previously approved during last term's lockdown which is inclusive of our ELC.

From **October 6**, schools will be open for on-site learning for VCE Unit 3/4. Oakleigh Grammar welcomes back all Year 12 students plus any Year 11 student studying a VCE unit 4. [Note: Year 11 students are authorised to attend on - campus only on the days they have a VCE Unit 4 lesson.

From **18 October**, on-site learning will be open for Prep on Monday, Tuesday and Wednesday; and for Years 1 and 2 on Thursday and Friday.

Out of school hours care can operate on all days at our ELC.

From **October 26**, on-site learning will be opened for Years 3 and 4 (Tuesday and Wednesday); Years 5 and 6 (Thursday and Friday); Year 7 (full-time, five days); Years 8 and 9 (Tuesday and Wednesday); Year 10 (Thursday and Friday); and Year 11 (full-time, five days).

ELC returns to normal operations where parents are fully vaccinated.

From **November 5**, schools can provide onsite learning for all levels.

Our School will maintain our commitment to high quality Remote Learning via the OG Remote Learning model for all students who are not eligible to return to School in accordance with the indicative dates above. More information will be provided to you as dates are confirmed during the month of October.
